Selection of a Consultancy Firm to Provide Services for the Project on Accession to Madrid Protocol

Expression of Interest (EOI)

National Intellectual Property Office (NIPO), established under the Intellectual Property Act, No. 36 of 2003 is mandated with the tasks of registration of trademarks, industrial designs and patents, and protection of rights related to copyright. Presently applicants of trademarks or service marks who submit their applications to NIPO seeking registration do not have the facility to obtain international registration through NIPO within the existing legal framework.

Accession by the Government of Sri Lanka to the Madrid Protocol administered by WIPO, a specialized agency of the United Nations Organization (UNO) for Intellectual Property services, policy information and cooperation would offer trademark or service mark applicants to secure protection for their marks in multiple jurisdictions. Applicants are accordingly required to file one single application, and pay one set of fees to obtain international registration in multiple jurisdictions which are signatories to the Madrid System.

Having taken into consideration the proposals made by the business community and the exporters, the Government of Sri Lanka has now taken a policy decision to accede to the Madrid Protocol. The activities in this respect have already been initiated by NIPO during 2016. It is envisioned to complete the tasks of appointing an accession team to attend to the work prior to acceding the Madrid Protocol, by proposing suitable draft amendments to existing trademark laws to be in line with the provisions in the Madrid Protocol, modernization of information technology systems and upgrading of the automated systems and compilation of

documents to deposit to ratify the Madrid Protocol. Accordingly, NIPO is in the process of

obtaining the services of suitable human resources to carry out the work at NIPO through

external service providers

National Intellectual Property Office invites the competent companies to submit their

expertise in similar activities. The company which will be selected for this purpose is anticipated
